Testate (Deceased has left a will appointing an Executor)

- Collection of all assets due to the Estate;
- Payment of all liabilities due by the Estate;
- Calculating or arranging for the calculation of the relevant tax due and preparing the documents to be submitted to HM Revenue and Customs for tax liability for the Estate;
- Preparing and accounting for all funds received and all payments made during the administration of the Estate;
- Distribution of the Net Estate to the Beneficiary/Beneficiaries in accordance with the deceased's will, considering any legal rights there may be and obtaining either waivers of rights or calculating the legal rights and making payment to any claimant.

- Preparing application for specialized insurance policy known as a Bond of Caution. This policy is a requirement of the Sheriff Court for application for Confirmation;
- Obtaining Confirmation;
- Collection of all assets due to the Estate;
- Payment of all liabilities due by the Estate;
- Calculating or arranging for the calculation of the relevant tax due and preparing the documents to be submitted to HM Revenue and Customs for tax liability for the Estate;
- Preparing and accounting for all funds received and all payments made during the administration of the Estate;
- Distribution of the Net Estate to the Beneficiary/Beneficiaries in accordance with Scots Law of Intestacy, considering any legal rights there may be and obtaining either waivers of rights or calculating the legal rights and making payment to any claimant.
